Being an Effective Foster Carer:

Helping to Understand Education and Training from 0 to 25, an Aide Memoire

Foster Carers have a key role in supporting the children they look after. A major part of that will be supporting the child with their education. A good education is vital for looked after children – it is a stabilising factor in lives that are too often characterised by instability. A good education will give them more opportunities to do well in their lives. We know that looked after children do not do as well as their peers. It is vital that foster carers understand why this happens and what they can do to improve the chances of the children they are caring for doing well. We have set out below the areas we believe will help foster carers to develop a greater understanding of why education is important and the important role they play. Our expectation is that those providing training for foster carers will use this aide memoire to ensure that the training they deliver allows foster carers to be truly effective in the support they give looked after children.
